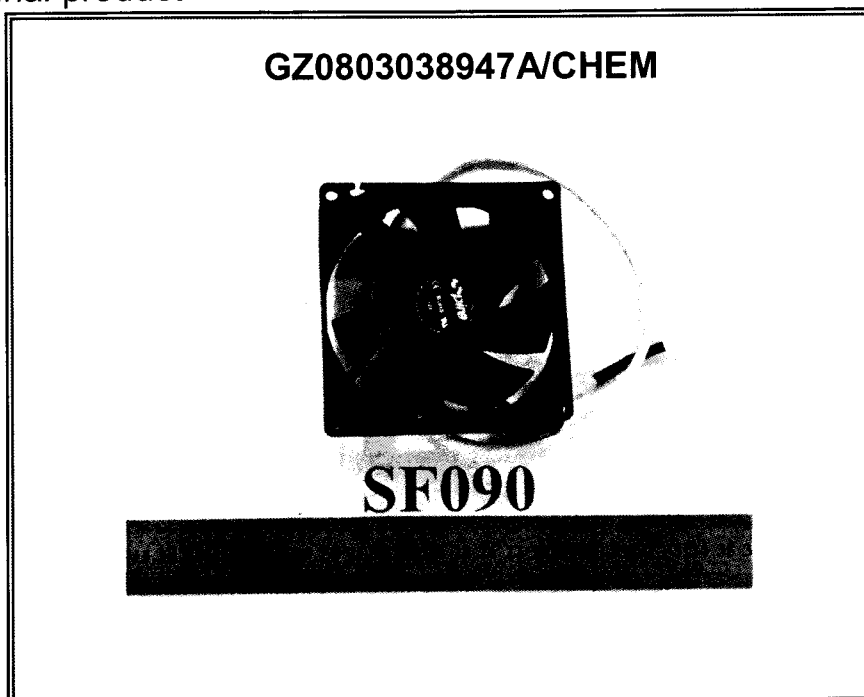
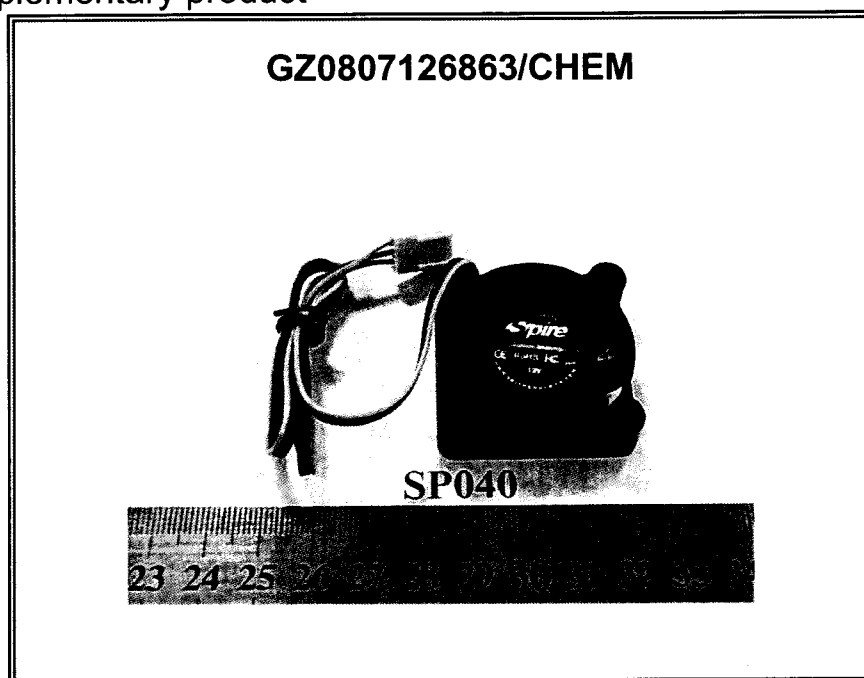


Photo for supplementary product

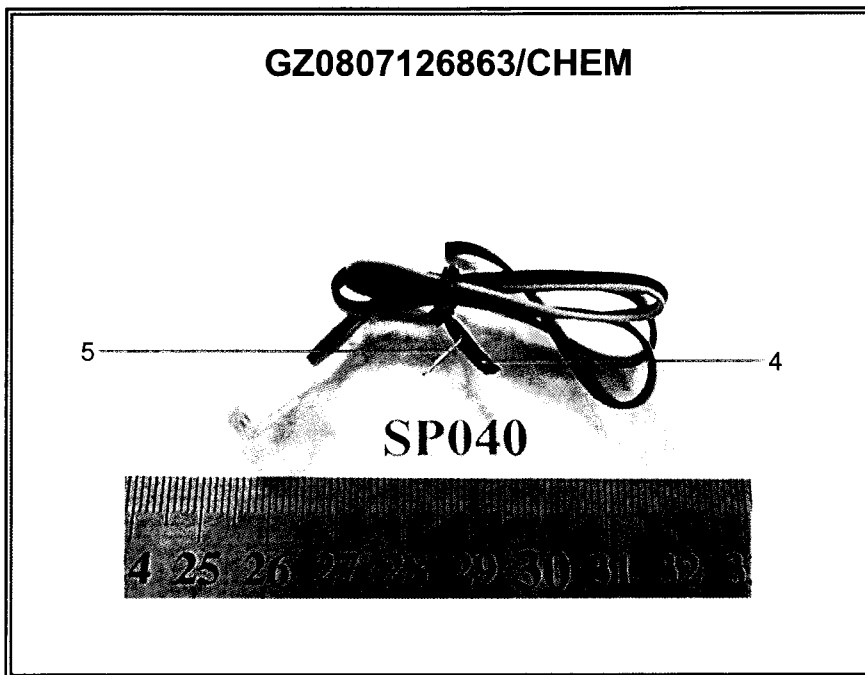
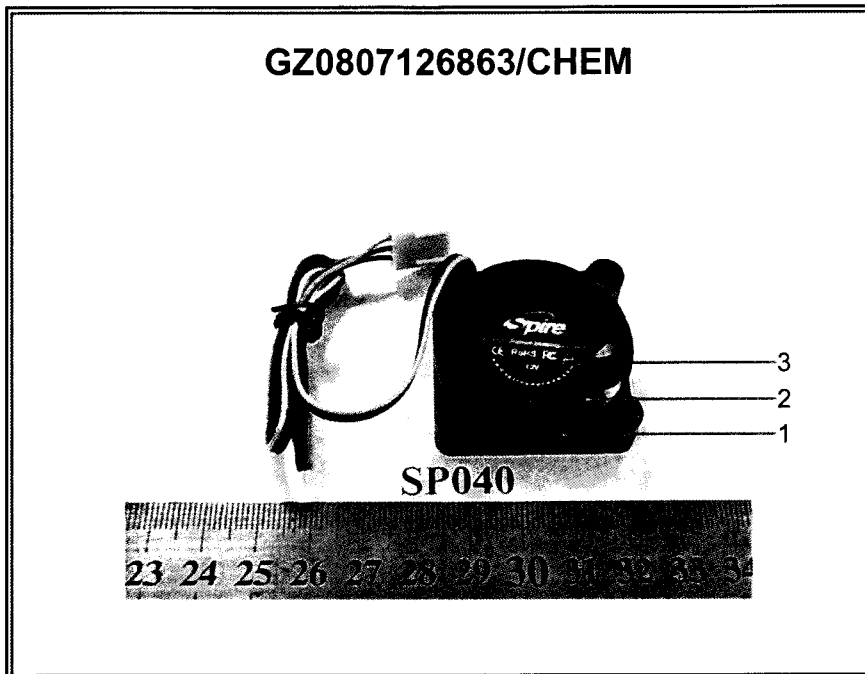
