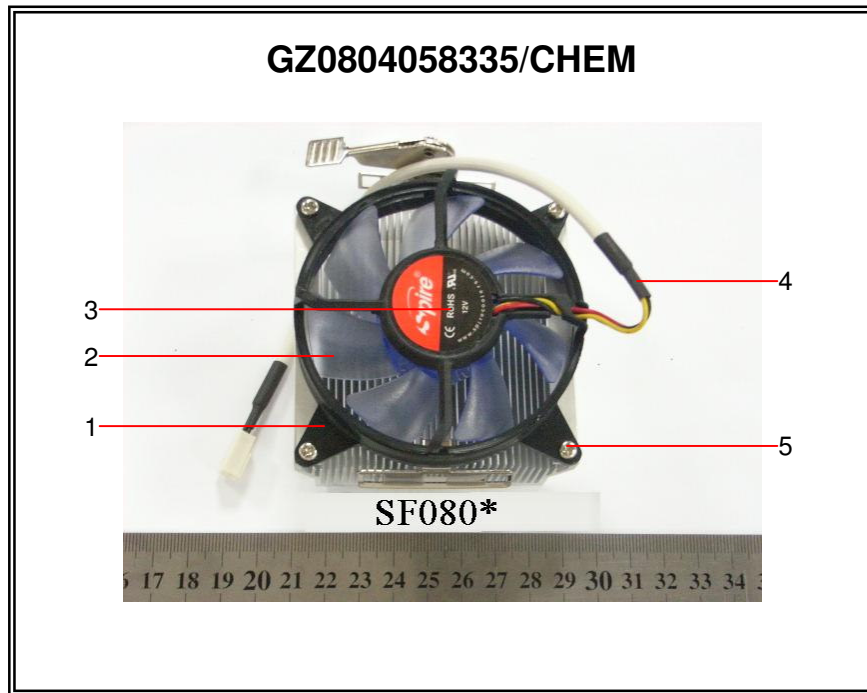
- (c) According to IEC 62321, Ed.1 111/95/CDV, result on Cr^{6+} for metal sample is shown as Positive/Negative.
